GUIDELINE FOR AUTHORS

✎ Both articles and abstracts are accepted for publication. The organizers encourage the authors to submit articles.

✎ **Requirements for articles:** Microsoft Word format (.doc or .docx), Times New Roman, font size 14, spacing 1.5. Margins: top, bottom, right, left - 2.5 cm.

The structure of an article must comply with the following:

- **THE TITLE** (capitalized, normal (regular) characters, centred)

- **Full name and surname of the author (s)** (normal (regular) characters, centred) No more than 6 authors are recommended.

- **Affiliations of the author (s)** (normal (regular) characters, centred)

Name of the institution and country. To facilitate the identification of the author and institution, Arabic numerals will be used in the upper (superscript) index, placed after the author's name and in front of the institution's name.

- **The article summary** must contain: introduction, materials and methods, results, conclusions, and keywords, limited to a maximum of 250 words.

- **Full-body text** must contain: Introduction, Purpose of the research, Materials and methods, Results, Discussions, Conclusions, List of abbreviations used (if applicable), and Bibliography. Images (photos, drawings, figures, schemes, diagrams, tables) must be numbered in the order of their appearance. The caption of such images will be placed beneath it in each case. Each image or figure will have a title, written in normal (regular) font below the image after the number of the image or figure.

- **References.** Bibliographic references will be numbered using Arabic numerals in the alphabetical order of the first author and will be included in the text in square brackets [1]. Bibliographic references must include authors (name and initial of the first name), title of the cited article (in the original language), journal (international abbreviation), year of publication, volume, and number of pages. Ex.: *1. Devaney E.J., Esophagectomy for achalasia: selection and clinical experience. Ann. Thorac. Surg., 2001; 72(3):854-8.*

- **At the end of the manuscript**, the author's full name, professional and scientific titles, name of the institution, city and country, e-mail and ORCID ID will be indicated. The responsible/correspondent author will be shown using * in the upper (superscript) index placed in front of the author's name.

The article volume will be between 10 and 18 pages and will contain a maximum of 50 references.
